BEGINNING at a point in the division line between lands now or formerly of Pennsylvania Coal Company and lands now or formerly of the Hudson Coal Company, being also the division line between Jenkins Township and Laflin Borough, marking the southerly corner of a parcel of surface conveyed by Pennsylvania Coal Company to William Mudlock and wife, by deed of release and quit claim dated February 8, 1968;  
THENCE North fifteen degrees forty five minutes West (N. 15 degree 45'W.) along the southwesterly line of said parcel of surface conveyed to William Mudlock and wife, two hundred twenty two (222) feet to the westerly corner thereof;
