BEGINNING at a point on the southerly side line of the one hundred (100.00) foot wide state highway, legislative route number 933 leading from Oliver Mills to Forest Park and in the line of lands of Margaret E. Behrens. said beginning point being distant one thousand seven hundred and eighty one hundredths (1700.18) feet measured in a course of north eighty-four degrees (84), fifty-four (54) minutes east, along the southerly side line of said state highway from the easterly side line of a fifty (50.00) foot wide private road, leading from said highway through lands of Margaret E. Behrens to Trailwood Lake;
