Beginning at an iron pipe found along the northwesterly line of Main Street (L.R. 40038), said pipe also being the southeasterly common corner of land between the grantor herein and lands now or formerly of Gino & Nancy Esopi;

Thence along Main Street, South 64 degrees 45 minutes 00 seconds West, ninety-five and no hundredths (95.00) feet to a rebar found along lands now or formerly of Robert Thomas and Joan Alesczyk;
