THE FIRST THEREOF:

BEGINNING at a point in the westerly line of Martin Street, the said point being located 114 feet southerly along the line of Martin Street from the southerly line of Middle Road;

THENCE along the westerly line of Martin Street, South 16 degrees East sixty four (64) feet more or less, to a point;

THENCE through Lot No. 16, as shown on a map hereinafter mentioned, South seventy four (74) degrees West eighty nine and eighty two one hundredths (89.82) feet to a point in the line of the plot of lots mentioned above;

THENCE along said line, North fifteen (15) degrees forty nine (49) minutes West forty five and five tenths (45.5) feet to a point common to Lots No. 1 and 16;

THENCE along line of Lot No. 1 and 16, North eighty five (85) degrees eight (8) minutes East twenty two and seven tenths (22.7) feet to a point in the center of Lot No. 1;
