ALL THAT CERTAIN piece, parcel or tract of land situate in the City of Hazleton, County of Luzerne and Commonwealth of Pennsylvania being the southerly one-half, more or less, of Lot No. 6 in Square No. 700 on the plot or plan of the Diamond Addition to said city, bounded and described as follows, to wit:

BEGINNING at a point in the westerly line of Roosevelt Street, said point being a distance of one hundred and sixty feet (160'), northwardly from the northwesterly corner of the intersection of Roosevelt and Thirteenth Streets and being in the line dividing Lots No. 5 and 6; thence northwardly along the westerly line of said Roosevelt Street for a distance of sixteen feet (16'), more or less to a point in the line passing through the center of dividing partition of a double dwelling house erected upon said Lot No. 6; thence extending of that sixteen foot (16'), more or less, width or breadth (between the northerly line of Lot No. 5 and the said line passing through the center of said dividing partition) in length or depth westwardly and at right angles to said Roosevelt Street for a distance of two hundred feet (200') to the easterly line of State Court;
