BEGINNING at a corner dividing Lots 4 and 5 in the northeasterly line of Pringle Street said corner being South 36 degrees 16 minutes East, one hundred sixty (160.00) feet from the intersection of the northeasterly line of Pringle Street and the southeasterly line of Korn Street, as shown on a map hereinafter mentioned;
