PARCEL I:

BEGINNING on the North side of Church Street in said City at a corner between Lot Nos. 103 and 104 on the plot of lots of the Susquehanna Coal Company recorded in Luzerne County in Deed Book No. 238, page 1; thence along the line of said Lot No. 103, North 18° 40' West, 73 feet to a corner; thence through Lot No. 104 North 71° 20' East, 50 feet to a point on the dividing line between Lot Nos. 104 and 105; thence along the dividing line of Lot Nos. 104 and 105, South 18° 40' East, 73 feet to said Church Street; thence along said Church Street, South 71° 20' West, 50 feet to the place of BEGINNING.
