THENCE South 44° 00' West 65.28 feet along the projection of the line common to Lots 12 and 14 to a corner on the Northeasterly side of land of the Delaware and Hudson Railroad;

THENCE 42.06 feet along the Northeasterly side of land of the Delaware and Hudson Railroad and along the arc of a 574.00 foot radius curve to the left having a chord North 28° 00' 22" West 42.05 feet to a corner;

THENCE in a southwesterly direction and in line with the easterly sideline of the existing lands of the Grantees herein, Thirty Eight and One One-hundredths (38.01) feet to a point, said point being along the southerly side of the aforesaid right-of-way;
