BEGINNING at a point in the northeasterly right-of-way line of the Lehigh Valley Railroad, West Side Connection, said point being the northeasterly corner of a parcel of land conveyed to John D. Harkins by the Lehigh Valley Railroad Company by Deed dated November 28, 1947, and recorded in Luzerne County Deed Book 972, Page 274, the said corner being located along said right-of-way line North thirty degrees West, two hundred ten and seventy-five hundredths (210.75) feet from its intersection with the northwesterly line of Wyoming Avenue.

THENCE along the above-mentioned right-of-way line, North thirty degrees West, twelve and forty-five hundredths (12.45) feet to a point;
